## EQUIPMENT RENTAL & LIABILITY RELEASE AGREEMENT

1. I accept for use **AS IS** the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this form, but not returned to the shop. I agree to return all rental equipment by the agreed date above.
2. I agree to hold harmless and indemnify the ski resort and its owners, agents and employees, as well as the equipment manufacturers and distributors for any loss or damage, including any that results from claims for personal injury, death or property damage, related to the use of this equipment.
3. I understand that there are inherent and other risks involved in the sport for which this equipment is to be used, **skiing and snowboarding**, that injuries are a common and ordinary occurrence of the sport, and I **freely and voluntarily assume these risks**.
4. I understand that the binding system cannot guarantee the user's safety. In Downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In Snowboarding, Cross-Country skiing and Snowblade use, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation.
5. In the case of helmet rental, I understand that no helmet can protect the wearer against all foreseeable impacts and injuries to the head and will not protect against neck, cervical, spine or any other bodily injuries.
6. I hereby release from any legal liability the **ski resort** and its owners, agents and employees, as well as the equipment manufacturers and distributors of this equipment from any and all liability for damage and injury or death to myself or to any person or property resulting from the selection, installation, maintenance, adjustment or use of this equipment, and for any claim based upon negligence, breach of warranty, contract or other legal theory, accepting myself the full responsibility for any and all such damage, injury or death which may result.
7. For release bindings only: I have confirmed that the binding release/retention setting numbers on the bindings correspond to the "Final indicator setting" stated on this form. I understand that the correct weight, height, age, and skier type are essential to proper adjustment of the release/retention settings, and I certify that all user information on this form is correct.
8. **This agreement is governed by the applicable law of this state. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.**
